From Austin, MN

Take I-90 East out of Austin to MN-56. Turn right and head south on MN-56. Turn right and head south at 730 Avenue/CR-T62. Turn left and proceed east on IA-9 into Riceville.

Travel Time: 1 hour

Travel Miles: 40

Decorah, IA

Take IA-9 West out of Decorah. Continue on IA-9 West into Riceville.

Travel Time: 1 hour 10 minutes

Travel Miles: 44

Mason City, IA

Take S Federal Ave/US-65 South out of Mason City. Turn left/East and take US-18 East. Turn left/North and proceed on US-218. Turn right/east onto IA-9. Continue on IA-9 into Riceville.

Travel Time: 1 hour 15 minutes

Travel Miles: 53

Rochester, MN

Take US-52 S to US-63 S toward Stewartville. Exit US-63 S and merge onto I-90 W. Take CR-6 exit and turn left onto CR-6/CR-8. Turn right onto CR-8 and then another right onto 290 ST/CR-1/CR-8. Proceed straight onto CR-8 until MN-56. Turn left/east on MN-56. Turn right/south onto 110 St/755 Ave/CR-6. Continue on CR-6 until 730/CR-9. Turn left/east on CR-9 which becomes CR-T62. Turn left onto IA-9 and continue into Riceville.

Take US-63 N out of Waterloo to IA-9. Turn left/west and proceed on IA-9 into Riceville.
